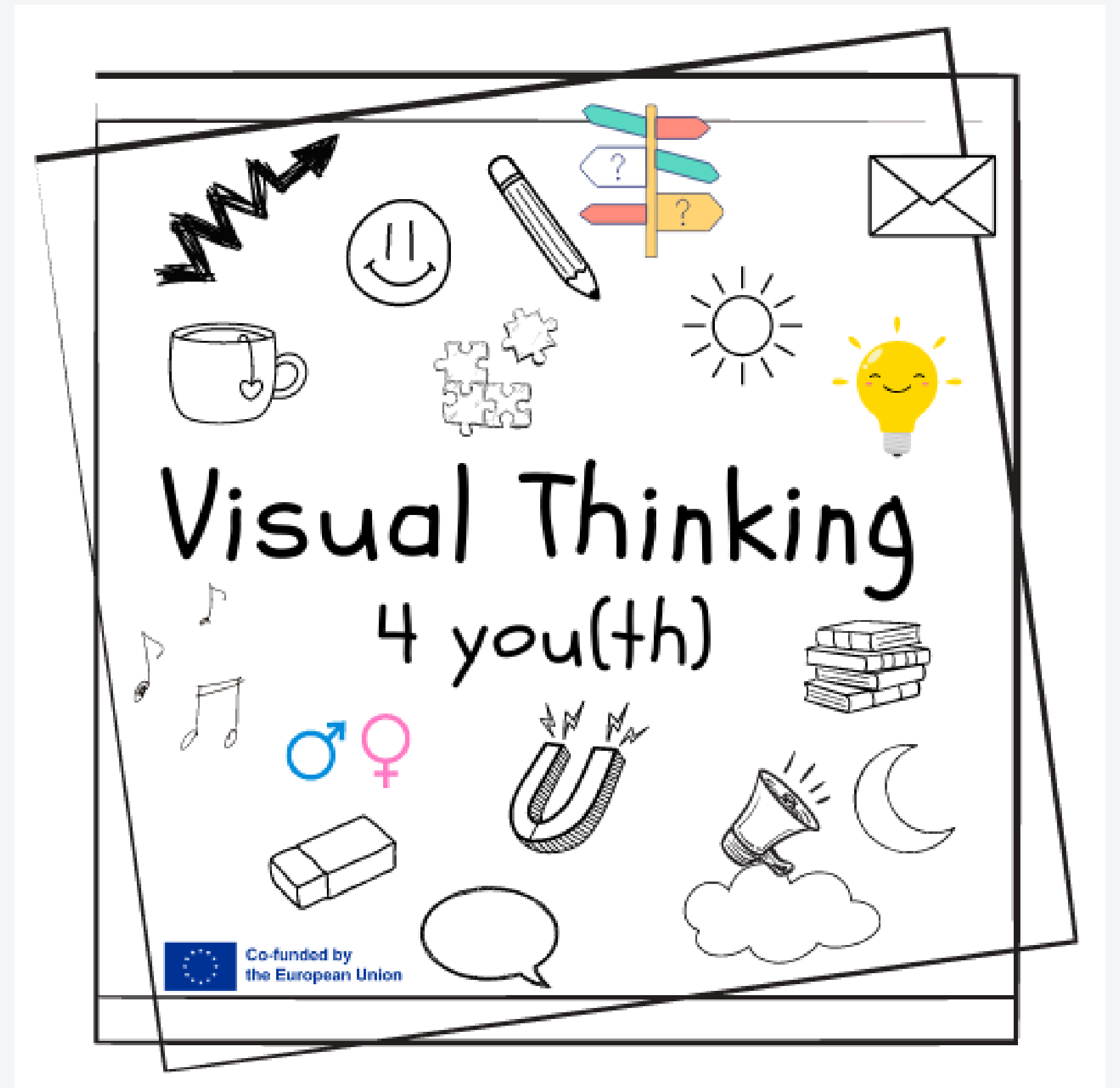

ABOUT THE PROJECT:

The Visual Thinking 4 You(th) project, has the general objective of promoting the social inclusion of dyslexic young people between 13 and 19 years old, through visual thinking, which consists in transmitting and exposing ideas through simple and easily recognizable images.

specific objectives are:

1. Improvement of the degree of knowledge by the youth workers of dyslexia and the potential of visual thinking as a tool for inclusion and learning. At the end of the first training activity will be recorded an improvement of at least 60%.
2. Construction of communication strategies to engage dyslexic youth ages 13-19 within youth organizations that offer innovative and complementary learning approaches to formal education. At the end of the first workshop, the percentage of youth approaching these organizations will increase by at least 30% over the values initially recorded;
3. Creation of learning methodologies focused on visual thinking specifically for dyslexic youth in order to increase their degree of integration and learning. At the end of the second workshop, the approach adopted with young people aged 13-19 will be at least 60% more effective and integrative than more traditional methodologies.

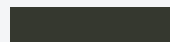

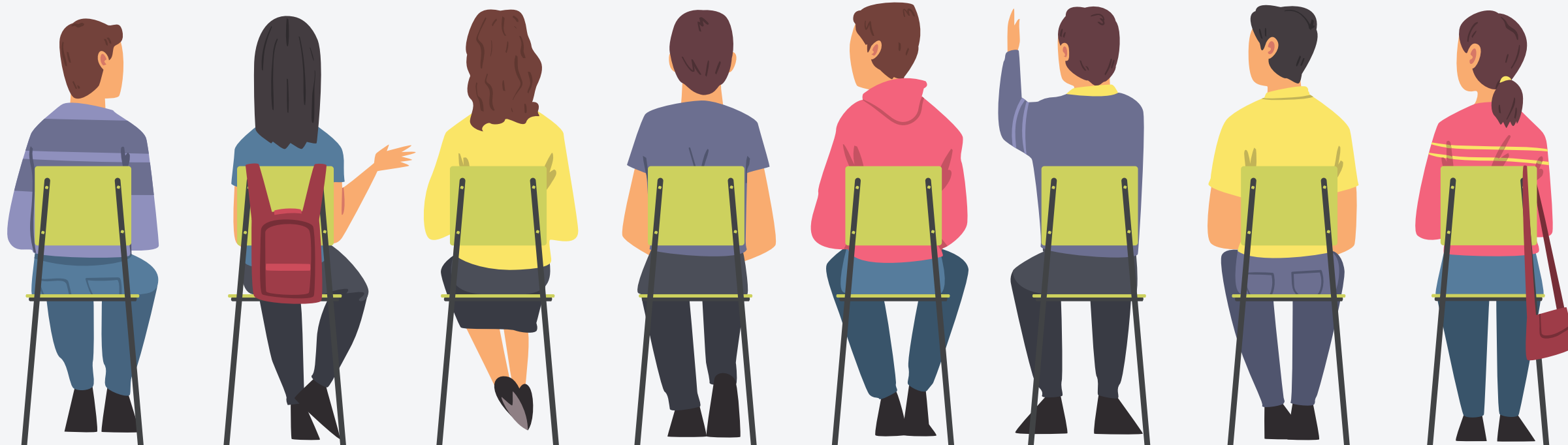


PARTICIPANTS

ECONOMIC RULES

For this Transnational Meeting EACH PARTNER GROUP will organize its own trip in autonomy and independently. Accommodations reservation, Food, Transports will be organized and managed by individual participants / groups. The coordinator will not be responsible for your stay in the Venue. All expenses will be paid in advance by the participants.

The maximum for person is **€ 575,00 (FOR TRAVEL, FOOD AND ACCOMODATION)**
SOS DIRITTI E LEGALITA' will reimburse the costs by bank transfer after the delivery of the supporting documentation.

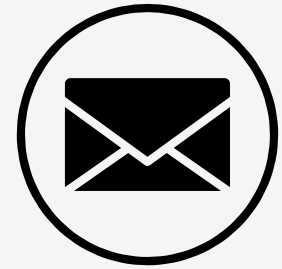
ECONOMICS RULES & REIMBURSEMENTS

Costs for subsistence (cost of accommodation, meals, local travel within the place of mission and sundry expenses) are eligible up to the actual amount spent. It is thus very important to keep all supporting documents (**BOARDING PASS** and tickets) . These may be requested by the Agency before making the final payment but should be kept available in any case for a possible ex post audit/control.

To be considered eligible, these costs must be reasonable, conform to local prices and be exclusively linked to the project. Lost, fake or incomplete documentation will not be reimbursed. The BANCORMAT PAYMENT RECEIPT alone is not eligible, it is eligible only together with the fiscal receipt.
